I. Extent of the life-cycle of plastics

Main topics/guiding questions:

- a. Under what conditions should the ILBI reflect interlinkages between plastic pollution and production of plastics to address the full life-cycle and set an overarching goal to reduce primary plastic production in order to end plastic pollution?
- b. What is the role of financial incentives, such as market- and price-based measures, and their effects on market dynamics, e.g. to internalise external environmental cost or to stabilize markets?

II. Relation of upstream and downstream measures

Main topics/guiding questions:

- a. How may global restrictions, prohibitions, phase-outs and requirements, for certain plastic products, contribute to the goal of ending plastic pollution?
- b. How can better product design shape the future of a safe, circular economy and reduce plastic pollution and which product or application categories should be prioritized?
- c. How can the global community improve the systems needed to handle plastic waste, including legacy waste in the environment?

III. Historic and future roles of states and private sector

Main topics/guiding questions:

- a. What needs to be the role of public and private sector in mobilising financial resources for implementing the instrument and what is the function of a financial mechanism considering the wider financial landscape?
- b. Does the treaty need to include regulatory or policy measures to address public and private financial flows?

- a. How to implement extended producer responsibility and assure comparability?
